- The addition of a districtwide behavior intervention specialist to work with students and staff
- · Access to a school-based social worker for students at all district schools
- A gifted and talented education specialist to enrich student programming
- Greater student access to digital learning tools
- A replacement cycle for outdated classroom furnishings, large band instruments, and curriculum materials

Kindergarten to Start on September 6

ISD 199 strives to make school a welcoming place and a personalized learning experience from each student's first day. To help students transition when they start at a new school, the district has separate first days for incoming 6th graders, 9th graders, and, starting in the 2018-2019 school year, kindergarten students. The first day of kindergarten will be Thursday, September 6, 2018, two days after school starts for students in grades 1-5. The extra days will help:

- provide a personalized welcome for each incoming kindergarten student and family
- introduce families and students to the kindergarten classroom, materials, and routines
- begin initial assessments to determine student strengths and needs to inform starting points for instruction and goal setting
- provide more staff and student mentors to support kindergarten students with bussing, meals, navigating the building, and other school routines

2018-2019 Bus Routes



Families will soon receive their student's bus information, including bus letter or number as well as pickup and dropoff locations and times. Families of students who receive special services will be mailed bus information, and families of all other student bus riders will receive information in an email.

COMMITTEE RECOMMENDS FLIPPED SCHEDULE AFTER SURVEY REVIEW



After gathering and providing more information about school start and end time options and their impacts, the district made a survey available to parents, students, employees, and community members. The survey, which opened in May, asked respondents to share potential positive aspects of and concerns about the two school start and end time options that the ISD 199 School Start and End Time Review Committee identified as practical: the current schedule of 7:40 AM - 2:30 PM for secondary schools and 8:30 AM - 3:10 PM for elementary, and a flipped schedule of 8:30 AM - 3:20 PM for secondary schools and 7:50 AM - 2:30 PM for elementary schools. The survey revealed that the community prioritized student sleep and schedules for child care, work, and activities. After considering these results, the committee is recommending that the ISD 199 School Board consider the flipped schedule for the start of the 2019-2020 school year.

Based on the district's total population of parents, students, and employees, less than 14% of all possible parent, student, and employee respondents participated in the Community Perspectives on School Start/End Time Options survey. Of the respondents, most were parents of elementary school students. The committee discussed the survey results before deciding to recommend that the district implement the flipped schedule and build a transition plan to help families and staff adjust in the year leading up to the change.

Before the school board makes a final decision on whether to approve the flipped schedule, the board is considering the committee's recommendation as well as the survey's results, and it will invite the community to a listening session to gather any community comments. A final board vote on the school start and end time decision for 2019-2020 is anticipated at the September or October board meeting.

Behavior Intervention Specialist to Address Districtwide Mental Health and Behavior Needs





Immunizations Required Before Back to School



Minnesota state law requires that students receive vaccinations to enroll in child care, early childhood programs, and school. Parents must submit written proof of vaccinations before enrolling. Visit **www.health.state.mn.us/immunize** for information about required vaccinations for enrollment.

Non-Resident Open Enrollment

Students living outside district boundaries may apply to enroll in Inver Grove Heights Schools through the Minnesota Enrollment Option Program. Non-resident students are encouraged to apply to the district by January 15, 2019, to be considered for enrollment in the following school year.

Non-resident applicants are also encouraged to request the school(s) they wish to attend. The district assigns transfer students to schools based on their preference and whether that school has space available. Students who are accepted under the Enrollment Options Program can remain in the district through grade 12, but they will be assigned to schools that have space available.

Notice of Pesticide Use

Inver Grove Heights Schools maintains its property for the safety of students, staff, and visitors and the longevity of its facilities. To do this, the district uses a limited number of pesticides and herbicides in and around its buildings and only when and where it will not affect occupants. The district's only herbicide is dandelion preventor, which is only applied during summer break. Applications are typically in June and August and always when there is no scheduled use of the affected area.

The district applies pesticides only on an as-needed basis. A pest elimination service inspects each building monthly and applies only the least harmful pesticides, which the Environmental Protection Agency labels category IV, in affected areas. Pesticides are applied, on average, twice per year in each building and always on non-school days.

State-Required Background Checks

Notice is hereby given that ISD 199 complies with state law requiring school districts to perform criminal history background checks.

ISD 199 obtains criminal history checks on everyone offered employment in the district as well as selected volunteers and independent contractors, including volunteer coaches, with the exception of enrolled students. In exercising its discretion with respect to independent contractors and volunteers, the district considers such factors as the amount of student contact and the duration of the contract.

The district does not perform background checks on the staff or volunteers of outside clubs or organizations that offer activities for youth in the community that are not organized or operated by the district.

Asbestos Management Plan

The district maintains a plan for managing all building materials that contain asbestos. The district is also in full compliance with the Environment Protection Agency's Asbestos Hazard Emergency Response Act and inspects all materials for damage every six months. The district also performs a major quantitative re-inspection every three years, per EPA statutes.

During the past year, there were no asbestos removal projects beyond small-scale maintenance. For the upcoming year, there are no asbestos removal projects planned at this time. Details on the locations, condition, and type of asbestos-containing materials as well as copies of building management plans are available at each building and at the ISD 199 District Office.

Notice of Indoor Air Quality

ISD 199 maintains an Indoor Air Quality Management Plan. The plan is based on the Environmental Protection Agency's Tools for Schools model indoor air quality program, which is designed specifically for school buildings. The plan's goal is to promote an indoor environment that enhances learning for students as well as productivity for staff. Accident Insurance

Currently, ISD 199 does not provide accident insurance for injuries that happen to students at school or during school activities. Parents who wish to have this type of accident protection are encouraged to contact an insurance company.

Educational Record Access

A student's education records will be transferred to other educational institutions upon transfer of the student. Parents, guardians, or students 18 years of age or older also have the right to inspect and review the education records maintained by the district. Such information will be disclosed to the authorized requestor except when federal or state law bars disclosure. A request for disclosure may be made to the school's principal. You have the right to request an amendment to your student's education records to ensure that they are not inaccurate, misleading, or otherwise in violation of the student's privacy or other rights.

Non-Release of Information to Military Recruiters

Notice is hereby given that parents of students under 18 years of age and students who are 18 years of age or older may refuse the release of directory information to military recruiters. The State of Minnesota's Government Data Practices Act section on Military Recruitment states:

A secondary institution shall release to military recruiting officers the names, addresses, and home telephone numbers of students in grades 11 and 12 within 60 days after the date of the request, except as otherwise provided by this subdivision. Data released to military recruiting officers under this subdivision:

(1) may be used only for the purpose of providing information to students about military service, state and federal veterans' education benefits, and other career and educational opportunities provided by the military; and

(2) shall not be further disseminated to any other person except personnel of the recruiting services of the armed forces.

A parent of a student, or a student who is 18 years of age or older, has the right to refuse the release of the name, address or home telephone number to military recruiting officers. To refuse the release of the above information to military recruiting officers, a parent of a student, or a student who is 18 years of age or older, must return the non-release form, located on ISD 199's website at **www.isd199.org/parents** under "Military Opt-Out Form" in the sidebar, by September 1 of each year. A new request must be completed each year.

A parent or eligible student's refusal to release the above information to military recruiting officers does not affect the district's release of directory information to the public, which includes military recruiting officers. In order to make any directory information about a student private, a parent or eligible student must return a Non-Release of Directory Information form, which is also located at www.isd199.org/parents under the "Directory Non-Release Form" in the sidebar.

Non-Release of Directory Information

Unlike educational records, businesses, organizations, and any member of the public can request directory information about students attending Inver Grove Heights Schools. Directory information is defined by Board of Education Policy 515 – Protection and Privacy of Pupil Records, which also governs its release:

Directory information means information contained in an education record of a student that would not generally be considered harmful or an invasion of privacy if disclosed. It includes, but is not limited to: the student's name, address, telephone listing, photograph, major field of study, grade level, participation in officially recognized activities and sports, weight and height of members of athletic teams, degrees, honors and awards received, and photos for school-approved publications or newspapers or cablecasts, bulletins, programs, or similar school-produced information pieces. It also includes the name, address, and telephone number of the student's parent(s). Directory information does not include personally identifiable data which references religion, race, color, social position or nationality.

If you are a parent of a student who is younger than 18 years of age or if you are a student who is 18 years of age or older, you have the right under federal and state law to direct the district to not release directory information. If you do not want this information released for anything other than district use, you must sign and return a Non-Release of Directory Information form to the school your child attends. Download the form by visiting **www.isd199.org/parents** and clicking "Directory Non-Release Form" in the sidebar. You will select "Please keep directory information private except for district use."

If you want to direct the district not to release directory information to military recruiters, you must also fill out the "Military Opt-out Form," which is also available for download at **www.isd199.org/parents** in the sidebar.

The directory non-release request will remain in effect for the remainder for the school year in which it is made. A new request must be completed each year.

Homeschool Reporting

Families living in ISD 199 district boundaries who plan to homeschool their children or whose children will attend an unaccredited nonpublic school for the 2018-2019 school year must submit an annual Full Report or Letter of Intent to Continue as required by state law. The deadline to submit reports for 2018-2019 is October 1, 2018.

Bowling State Qualifiers All Place in Top Ten Spots



One of Simley High School's 2017-2018 bowling teams sent five of its 16 members to state this May. The students qualified in both Doubles and Singles. All of the state qualifiers placed in the top ten, including three state champions.

They faced 28 other teams to take the top two spots in the category. Emily and Brianna also won the top two spots in their Girls Singles category out of 34 competitors. Brianna earned second place and Emily became the state champion in this Singles category along with her championship win in Doubles. Dallas became the state champion in Boys Singles, and Thomas took 3rd in the same category. They faced 32 others in their category. Seniors Recognized for Outstanding Performance as Student Athletes

At the end of the 2017-2018 school year, Simley High School honors its seniors who have done outstanding work in academics, activities, and athletics. This year, the school honored dozens of seniors who have shown leadership as student athletes.

Simley honored every senior who had participated in three or more sports throughout their four years of high school. The Simley Spartan Award was presented to 21 seniors.

Nearly 20 seniors were also honored with the Metro East All Conference Academic Award. To earn the award, seniors had to have a 3.65 GPA and be named All Conference in a sport. Three of the honorees, Kayla Anderson, Mindy Kolodziejski, and Danielle Ungurian, were also recognized for maintaining 4.0 GPAs.

Senior Hailey Scheffknecht received the St. Paul Athena Award alongside 42 other student athletes from the east metro area. The

award recognizes female student athletes who display excellence in athletics as well as academics. Hailey was a two-sport athlete, focusing on dance team and softball. She was also the first dance team member to be recognized with the Athena Award. This fall, Hailey will attend the University of Minnesota – Twin Cities.

Simley Students Launch Handmade Kayak



Simley High School students worked on building a kayak this spring with the help of Urban Boatbuilders. The organization helps students develop critical thinking and STEM skills while learning how to build different projects. Students celebrated their final product with a launch in Simley Pond.

During the year, students prepared to build the boat by learning about knots, water safety, and construction vocabulary. They spent about two months constructing the kayak itself, including sawing, sanding, lashing, waterproofing, and many other new skills. Though Urban Boatbuilders staff gave students guidance on building their boat, they also let them problem-solve issues that occurred during construction.

Students displayed the final project at the Simley and Inver Grove Heights Middle School Fine Arts Night, and then they launched it in Simley Pond to test it out themselves. During the launch, students read their reflections from the year, talked about their favorite parts of the build, and shared what they had learned. Urban Boatbuilders attended the launch to show students how to properly fit a life jacket, launch and board different kinds of watercraft, and paddle without tipping over. The organization's staff also brought other kayaks and canoes that they helped build for students to try, including a handmade paddleboard.



Simley hopes to bring the hands-on project back next school year to teach students STEM lessons and core life skills that will help them in college, career, and personal endeavors.
